Sustainability and Transformation Programme

- 7. Health commissioners and providers are required by NHS England to work together to develop STP plans which will integrate, update and streamline health and care provision. England is divided into 44 local STP 'footprints'.
- 8. The footprint for Cambridgeshire and Peterborough matches our Clinical Commissioning Group (CCG) area. Cambridgeshire and Peterborough Clinical Commissioning Group has worked with other organisations to establish a leadership model and a number of planning work streams. The Cambridgeshire and Peterborough STP was submitted to NHS England in June. See http://www.fitforfuture.org.uk. My July and November 2016 Chair's reports identified reasons and opportunities for public and patient engagement in the STP.
- 9. Following work with the CCG and new STP Delivery Unit programme director on improving patient and public involvement in the STP the Health and Care Executive have approved the principles of:
 - Shifting from concept to delivery
 - Supporting patient and carer involvement to improve services and in delivering change
 - Supporting public engagement to develop priorities, strategies and plans
 - Using community engagement to identify needs and aspirations
- 10. Further work continues with Delivery group communication leads to resource each group and project with appropriate patient and public perspectives.

Information about the local health and social care system

- 11. Matters noted during the period are as follows:
 - The Sustainability and Transformation Plan was launched to the public on 21st November (See above).
 - Cambridgeshire and Peterborough Clinical Commissioning Group has set out its vision for primary care. This is in response to the local funding opportunities described in the NHS England General Practice Five Year View. This investment is crucial to the recovery of the health system.
 - Addenbrookes, Hinchingbrooke and Peterborough and Stanford
 hospitals have been on 'black alert' over the winter holiday period.
 This is due to pressures of demand and on admissions, and the
 management of patient flow within hospitals and for appropriate health
 and social care services on discharge. A sustained public campaign to
 promote appropriate choice of urgent and emergency pathways is
 underway to compliment a range of system-wide strategies being

implemented through the STP, including placing GPs at the front door of A+E.

- Area Executive Partnership Boards are established, to help develop STP implementation in localities. They involve District Councils, GPs, health services locality teams, patients and Healthwatch.
- Hinchingbrooke Healthcare NHS Trust and the Peterborough &
 Stamford Hospitals NHS Foundation Trust approved their merger on
 25th November. The new Board is announced. Recruitment for Governors has closed.
- Cambridgeshire Health and Wellbeing Board considered a place based approach to tackling inequalities in health, and joint areas for action to support the health and social care workforce requirements.

Emerging joint working for Healthwatch Cambridgeshire

- 12. Interests raised during meetings (see appendix) are as follows:
 - C&PCCG mental health commissioners and Healthwatch Cambridgeshire are reviewing joint working with the Service Users Network (SUN).
 - We are grateful for your participation in our recent consultation on future closer working between Healthwatch Cambridgeshire and Healthwatch Peterborough. Stakeholder feedback, and discussions with the Boards and Staff of both Healthwatch, highlighted the need to develop a formal solution to ensure Healthwatch works in an integrated fashion across the whole Cambridgeshire and Peterborough patch whilst maintaining and strengthening its local presence. Following a meeting with our commissioners, this is supported as a direction of travel. A final decision will be made by both Boards before the end of January 2017.
