The meeting was recorded for the purpose of the minutes. GL also explained the 'Closed Captions'.

2 Minutes of the previous meeting and Action Log

The minutes of the meeting held on 16th November 2021 were approved.

The Action Log was reviewed. Actions 145 to 151 were completed. Action 142 is to be followed up with ASCF.

3 Feedback from Independent Members

- #1 Cared For's Financial Assessment letter stated review was usually within 4 weeks but that there were delays so it would be within 10 weeks. An assessor had been tasked. It was explained that the Carer had been required to submit papers within 2 weeks of being asked. Carer felt that the assessor had only been named as the Carer had raised this with Laura Green.
- A Carer noted that people feel trapped. If they are written to by someone, they should receive a direct dial phone number to speak to the person, rather than the phone number for a team.

Another Carer noted that the IT system should be able to send out automated letters to alert people to delays etc.

Carers noted that phoning the Call Centre means having to repeat the story each time

- #2 Carer's son shielded so didn't have support during the lockdowns. His support re-started, which has now stopped due to organisational difficulties due to Covid-19 related issues.
- #3 Contribution to care needs to be broken down better so that people understand how it has been calculated.

4 Feedback from other meetings and the Adult Social Care Forum

GL Attended the CCG's Learning Disability and Mental Health Delivery Board. It is currently weekly due to the NHS being in a Level 4 national incident due to the current wave of Covid-19. It was reported at this meeting that the number of people with Learning Disabilities taking up their Covid-19 vaccinations had increased since GP surgeries were allowed to deliver the vaccination.

5 Update from All-Age Carers Service

Caring Together reported:

Carers had a number of activities such as a visit to Sandringham

Christmas and New Year were particularly challenging for many carers, with

lots of "What Iff" plans being activated.

Gypsy, Roma, Traveller Carers - an Easy Read letter is being developed with partner organisations.

Centre 33 reported:

Working with schools to identify young carers

Busy with face-to-face support, some happened in-person then switched to online to protect young carers and their cared for.

Young Carers Advisory Board is recruiting new members

Training being delivered to professionals about young carers.
