3.		Update from the Learning Disability Partnership and SEND Welcome to Philippa who has joined the team.
		We are starting to get back to normal. Teams are working in small bubbles in the office, and we are now able to meet people in their homes.



Most staff have had their second vaccine.

We are doing a big recruitment drive.

We need a psychologist and an occupational therapist as due to lockdown our waiting lists have got bigger.



Karen Foody our lead LD nurse has retired, and Rebecca Ford is standing in in the meantime.



We are working with day providers to see how people can get to attending. We are checking to see if people still want to go.



We have been monitoring the hospital admissions since last March for people with learning disabilities. There have been 392 which is high.

Addenbrookes have a new disability liaison nurse and are recruiting for a children's one too.

We have been told lots of issues around bowels, so the community nurses have been making easy read leaflets for people.

Funding for the Future- Emma Grimes

Emma gave a presentation. She said that there is to be investment in LD and Autism services.

There are 3 overall aims

- To improve quality of care for people with a learning disability and/or autism.
- To improve quality of life for people with a learning disability and/or autism



 To enhance community capacity, thereby reducing inappropriate hospital admissions and length of stay.

We want to know if things are not good or if there is more than can be done.



We will be asking people their views and ideas.

There is money for the next 3 years.



£1.273 million for this year

£1.5 million for next year

£1.7 million for 2023



Emma was asked about LD health checks. She said there is more money for this and a specialist nurse is going to be employed to work with GPs to encourage the checks to be done and to find out why some people do not want to go for them.



Graham said he had been attending meetings with Susan Sadek which had been talking about health checks. Susan is temporarily away from her post and Graham has been missed off mailing list.


Update from other meetings
